1.

2.

Plaintiffs allege that the various ordinances and statutes governing the carrying of firearms in municipal parks are ultra vires and preempted by the Georgia Constitution.

Plaintiff GeorgiaCarry.org previously filed a substantially similar lawsuit with the Superior Court of Coweta County, case number 2007-V-215.

Coweta County Superior Court Judge Jack Kirby granted summary judgment to Coweta County on June 4, 2007.

5.

Plaintiff GeorgiaCarry.org appealed the Coweta court's ruling to the Georgia Court of Appeals.

6.

The Georgia Court of Appeals has yet to issue a ruling on the appeal, case number A07A2036.

7.

This Court has wide discretion over how it manages its caseload and civil calendars.

8.

A delay in proceeding with Plaintiffs' lawsuit will neither harm nor unduly burden Plaintiff as the nearly identical case is now before the Georgia Court of Appeals. WHEREFORE, City Defendants move this court to stay further proceedings on this matter until such time as the Georgia Court of Appeals issues a ruling in case number A07A2036.
