ORDER GRANTING MOTION FOR SUMMARY JUDGMENT IN FAVOR OF THE CITY OF ROSWELL AGAINST PLAINTIFFS AND DENYING PLAINTIFFS' MOTION FOR SUMMARY JUDGMENT AGAINST THE CITY OF ROSWELL

On May 9, 2008, the Court conducted a hearing on cross Motions For Summary Judgment filed by Plaintiffs and by the City of Roswell in the above-referenced case. Having heard the argument of counsel for Plaintiffs and for the City of Roswell, and after having considering the briefs filed with the Court in support and in opposition to each Motion, and having considered all matters filed of record, IT IS HEREBY ORDERED AND ADJUDGED that the City of Roswell's Motion For Summary Judgment is GRANTED and Plaintiffs' Motion For Summary Judgment is DENIED.

The Court notes that counsel for Roswell specifically stated for the record that Roswell had waived any issue regarding standing, and that counsel for Roswell specifically stated that Roswell had waived the requirement that Plaintiffs prove the original ordinance in question by filing a certified copy thereof with the Court. Counsel for Roswell stated that the original ordinance had been sufficiently proved by admissions in judicio.

Each party shall bear its own costs. Pursuant to O.C.G.A. § 9-11-54 (b), the Court hereby makes the express determination that there is no just reason for delay of entry of final judgment in favor of the City of Roswell, Georgia and hereby expressly directs that final judgment be entered in favor of the City of Roswell, Georgia.
